- NOTICE IS HEREBY GIVEN that the London Borough of Hammersmith and Fulham have made the above-mentioned Orders under the powers granted by sections 6, 45, 46 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended. The Orders will come into force on 22nd March 2023.
- The general effect of the above-named Orders will be, in connection with the introduction of improved cycle lane provisions in King Street, to:-

- (a) in King Street, between Nos. 10 and 364 King Street (the extent of King Street covered by this scheme):-
 - to remove all existing bus lanes and cycle lanes;
 - to provide two-way mandatory cycle lanes, operating "at any time" and segregated from the adjoining traffic flow (except in certain lengths to allow access to off-street facilities or adjoining roads or at pedestrian crossing points) by either carriageway island sites or segregating bollards, in the following lengths:-
 - the north side, from a point 9 metres west of the party wall of Nos. 6 and 8 King Street to a point 17 metres west of a point opposite the party wall of Nos. 43 and 55 King Street;
 - the north side, from a point 3.5 metres west of a point opposite the party wall of Nos. 73 and 75 King Street to a point 5 metres west of the party wall of Nos. 130 and 132 King Street; and
 - the south side, from a point 1.5 metres east of the eastern wall of No. 157 King Street to a point 9 metres west of the western wall of No. 393 King Street;
 - on both sides, excluding the north side, outside and west of No. 362 King Street and any locations where bus stops, pedestrian crossing facilities or the existing car club parking place outside No. 139b King Street are to be provided:-
 - to convert all single yellow line waiting restrictions to no waiting "at any time" restrictions (double yellow lines); and
 - to provide no loading "at any time" restrictions (double kerb-blip markings), including any lengths where there are existing single kerb-blip loading restrictions, except on the north side, outside Nos. 342 to 370 King Street, where loading restrictions operating on Mondays to Fridays inclusive, between 8am and 9.30am and between 4.30pm and 6.30pm will be provided;
 - on the north side:-
 - to remove Zone 'A' shared-use parking places outside Nos. 156 to 162 King Street (25 metres) and outside Nos. 146 to 152 King Street (32.5 metres) and provide Zone 'A' shared-use parking places outside Nos. 154 to 156a King Street (12 metres) and outside Nos. 162 to 166 King Street (18 metres);
 - to relocate the 12-metre loading bay from outside Nos. 152 and 154 King Street westwards by 23.5 metres, to outside Nos. 156a to 160 King Street;
 - shorten by 2 metres the 14-metre loading bay outside No. 134 King Street; and
 - to remove the loading bay outside Nos. 110 to 114 and No. 116 King Street (14.5 metres); and
 - on the south side:-
 - to remove the Zone 'A' shared-use parking places opposite Nos. 156 to 162 King Street (30 metres) and opposite Nos. 132 and 134 King Street, (18.5 metres);
 - to shorten by 13.5 metres the Zone 'A' shared-use parking place outside Nos. 129 to 135 King Street;
 - to remove the loading bays outside Nos. 81 to 85 King Street (16.5 metres) and outside Nos. 111 to 117 King Street (14.5 metres);
 - to provide loading bays (max stay 30 minutes, no return 1 hour) operating "at any time", opposite Nos. 154 and 156 King Street (12 metres) and outside Nos. 383 to 385 King Street (12 metres); and
 - to provide a loading bay (max stay 30 minutes, no return 1 hour) operating Monday to Sunday 8.30pm to 8.30am, outside Nos. 137a to 139a King Street (13.1 metres);
 - in Bridge Avenue, the east side, adjacent to No. 93 King Street, to provide a 12-metre loading bay (max stay 30 minutes, no return 1 hour) operating Monday to Sunday 8.30pm to 8.30am, replacing "at any time" waiting restrictions;
 - in Macbeth Street, to provide no loading "at any time" restrictions (double kerb blip markings) on both sides, for 8.5 metres south of King Street;
 - in Ravenscourt Avenue, to provide "at any time" double yellow line waiting restrictions, on the west side, for 10 metres north of King Street;
 - in Rivercourt Road, the west side, remove the Zone 'M' shared-use parking place adjacent to No. 231 King Street and replace it with single yellow line 'controlled hours' waiting restrictions; (f) in St. Peter's Square, the east side, adjacent to Nos. 395 to 403 King Street, to remove the solo motorcycle parking place and 6.5 metres of 'Zone 'M' shared-use parking space and provide a 12-metre loading bay (max stay 30 minutes, no return 1 hour) operating "at any time";
 - in Studland Street, the west side, outside Nos. 3 and 5 Studland Street, to shorten the Zone 'M' shared-use parking place by 8.5 metres (to allow for the provision of the bus stop referred to in paragraph 6(b) above); and
 - in Wetjje Road, to provide no loading "at any time" restrictions (double kerb blip markings) on both sides, for 5 metres south of King Street.
- For a period of 6 weeks from the day on which the Order is made, a copy of all Order and a copy of the Council's statement of reasons for making the Order and documents giving more detailed particulars of the Order can be inspected during normal office hours by contacting the Transport and Highways Department, Environmental Services, Town Hall Extension, King Street, Hammersmith, W6 9JU.
- If any person wishes to question the validity of the Order or any of the provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court.
