THE PROPOSAL WAS INITIALLY TO WIDE AS PER THE HILLINGDON SDP. THEREFORE THE SIZE OF THE GROUND FLOOR SIDE EXTENSION WAS REDUCED AS TO NOT BE MORE THAN 50% MORE THAN THE ORIGINAL WIDTH OF THE DWELLING. THE FIRST FLOOR EXTENSION AND THE REAR WAS ALSO REDUCED TO LINE UP WITH THE FIRST FLOOR SIDE EXTENSION AS ADVISED. OTHER SMALL AMMENDMENTS INCLUDING CHANGE TO PORCH WERE MADE TO INITIAL PRE-PLANNING APPLICATION DRAWINGS AS ASDVISED BY MR CHRYSANTHOU.
