The existing use of the land is for Residential Use Only and the proposed extensions & alterations will be solely for Residential use.

The proposed loft will:

- ii) Not extend beyond the plane of any existing roof slope, which forms part of a principal elevation of the dwellinghouse and fronts a highway.
- iii) Measure 46.46 cubic metres, and as such would not exceed the cubic content of the original roof space by more than 50 cubic metres (detached dwellinghouse).
- iv) The rear dormer would be inset by more than 200mm from the eaves of the existing main roof.
- v) The proposed front rooflights would project no more than 150mm above the roof plane and would be lower than the highest part of original roof.
- vi) All materials used would match those of the existing dwellinghouse.
