Details of the pre-application advice received

It was noted that the side first floor extension needs to be set back by 1m (which has now been amended to follow advice). Whilst the proposal would not breach the 45 degree line for ROT from the centre point of the first floor facing windows of both adjacent properties, there were concerns on the impact to neighbouring property of no.16. We have reviewed the layouts & pulled the first floor extension back closer to no.16. The roofline has also been altered to match that of the existing roof & the overall large crown has been reduced. The current proposed single storey rear extension is shown at 5m deep. This exceeds the 4m limit within Policy DMHD1 by 1m, however due to the extension being set in from the boundary line by 1m, the roofline being pitched to further reduce the visual impact & the rear garden to the property being in excess of 35m deep, we think that this property should be viewed within it's own context & deemed acceptable.
