Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposed works fall within the 'permitted development rights' under heading Class B. To meet the guidelines, the roof space created does not exceed 50 cubic metres. It does not exceed the height of the highest part of the existing roof and the materials proposed will be similar in appearance to the existing house. The dormer is set at more than the minimum of 0.2m in from the eaves. The proposed works fall within the 'permitted development rights' under heading Class C. To meet the guidelines, the roof lights will not protrude more than 0.15m beyond the plane of the roof slope.
