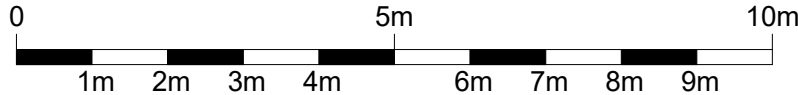


1 Side elevation 2 - Existing2

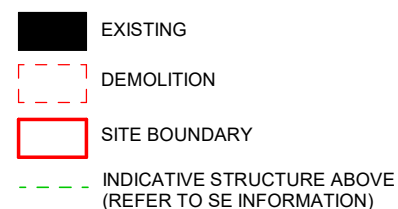
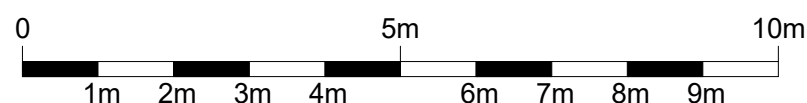
1 Side Elevation - Existing
