T1 Oak of MWA Arboricultural Report

Works: Reduce height to 10.0m and crown spread to 12.0m [6m radius] leaving a balanced crown and re-prune thereafter on a triennial cycle to retain at reduced dimensions.

Reason: Clay shrinkage subsidence damage at 23 Three Oaks Close, UB10 8DU.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
