Ref 398/3 - 7 photographs taken in November 2021 that were submitted to the Arboriculturist, and 5 photos taken in April 2023

Ref 398/4 - Written advice from an experienced professional landscape designer (Mr Jose Almeida) that the tree is at high risk of falling and if so may pose real danger to life and property

- TPO 398 area 1
- Oak tree in front (right) near the boundaries of 79 copsewood way and 77 copsewood way; facing the main street of copsewood way. At 79 copse wood way, northwood ha6 2tx. As clearly identified in the sketch provided herewith
- Fell the diseased tree and replace with a suitable alternative (e.g., hornbeam, cherry, oak)

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
