Prior to scheme being designed, informal advice on the general principal of the schemed was provided as follows:

Personally I would view this as one where the requirement of policy DMHD 1 C) vii) "in Conservation Areas, single storey side extensions may be required to be set back" as a situation where the 'may' should not apply. The rebuilt garage as a single storey side extension would still be subordinate to the original house and fit in with the street scene. I do like your idea of incorporating a half-brick set back to give a slight crease on the elevation. If this does work in relation to the floor layout, it contributes to the proposed front elevation, as numbers 9 and 11 seem to be the only 2 houses in this section with garages still set back from the front elevation. Worth applying for, I would consider.

First floor extension to the side and rear should also be possible , something similar to that at number 7 I would think. That was approved in 2011.
