Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

As above on the original TPO from 1971 the Cedar tree is shown as T40. It is sited in the grounds of Highfield House and it is the closest tree to the property. As you can imagine over the years it has grown to quite a size and is beginning to reach the building and has also become entangled in the telephone wire connected to the property.

All that is being proposed is that permission is granted to trim the diameter of the tree up to 2 metres around, which will negate any danger from the tree growing into the house and or neighbouring property. It will obviously also negate the damage being caused to the telegraph pole or cabling.

A tree surgeon has been consulted, which is where i got the 2 metre suggestion. As they felt that that amount was required to make the tree safe and to promote its health and well being as you can imagine over time there are a lot of dead branches that need removing and tidying up.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
