All existing windows and doors are white uPVC double-glazed units. Frosted glazing is present to the ground floor bathroom window on the west elevation and the first floor bathroom window on the south elevation.

Proposed materials and finishes:

The proposed extension will incorporate matching white uPVC double-glazed windows and doors. The rear elevation will include four-panel bi-folding doors, together with four roof lights within the proposed roof structure.

The existing roof is finished with concrete roof tiles.

Proposed materials and finishes:

The proposed extension roof will use matching concrete tiles to ensure consistency with the existing dwelling in terms of appearance, colour and material.

The existing property is finished in painted pebble dash in an off-white/cream colour, with green painted mock-timber panelling to the first floor north elevation and green painted rainwater goods. The front (north) gable elevation includes a dwarf-height redbrick course on the ground floor.

The proposed extension will continue the existing cream-coloured pebble dash finish to match the existing dwelling. To the rear (south) elevation, a half-height brick course will be incorporated to reflect and mirror the detailing present on the front (north) elevation.
