(T1)- English Oak(Quercus robur)

- reduce crown by 25%(1.8m max.)to suitable growth points
 - thin crown by 10% removing selected finer branches to allow more light through canopy and reduce wind-loading in upper canopy
 - reduce lateral side growth to match(1.5m) to suitable growth points
 - lift lower canopy by 1-1.5m w/emphasis on LHS to reduce shading in garden
- For general maintenance and care for mature tree

(T2) - Cypress(Cupressus)

- section fell to ground level as tree has out grown space and is encroaching into oak canopy-owner plans to replace with smaller indigenous species elsewhere in the garden
