Replace existing Gas Central Heating system with new green and energy efficient Air Source Heat Pump (ASHP).

The works will include the following

1. Decommissioning the existing Gas boiler and hot water tank
2. Installation and commissioning of new ASHP, hot water tank and upgrade to existing radiators
3. The works will require a 10 meter long, 0.45 meter wide and 0.6 meter deep trench to be dug from the back of the house towards the rear of the property straddling the fence which is the boundary between No6 (Proposer) and No4 (Neighbour). This will enable hot/cold water return pipes and electricity to be supplied to the ASHP unit located 10 meters towards the rear of the property.

The works will be carried out by an MCS certified installer.
