The facility is located wholly on/within the curtilage of the detached property site on the edge of Court Park, Hillingdon. The dog wash facility will be on a 3m x 2.5m plot on the west boundary, and will be serviced with water and power and drainage from the house plot. The activity will require a change of use from C3 to E for the activity/business of the dog wash. The house plot curtilage already has a cafe kiosk located some 5.5m south along the boundary of the plot which has permission through a condition amendment.
