Details of the pre-application advice received

To comply with policy it needs to be no more than ½ the width of the original house and have a 1m set-back from the front elevation. Whether this will allow for first floor accommodation I am not too sure. The other issue is to what extent we will be concerned about the amount of built development into the relatively "open" corner at Egerton Close. Possible impacts on the adjacent listed building cannot be discounted either. One option may well be to submit the proposal as drawn up and see what happens.
