Tree Number - T1
Tree Type - Western Red Cedar (*thuja plicata*)
Approx. Diameter at 1.5m - multi-stem 0.3-0.4m
Approx. Height - 14m
Approx. Crown Spread Diameter - 8m
Location - Rear garden left hand side near house
Service - Section dismantle
Work Required - Section dismantle tree to near ground level and leave the stump in the ground
Reason - The tree is a multi-stem specimen (comprising three stems), with one stem having completely died. This could indicate root decay or disease, which may compromise the tree's structural stability. Given its proximity to the property, a failure of the tree poses a significant risk of extensive damage and a high potential for severe harm to human health.

Tree number - T1
Location - Rear garden left hand side
Approx Diameter - 0.3-0.5m
Service - Stump Grinding
Work required - Grind out the stump to a depth of approx. 200mm below the stump's current ground level and leave all grindings. Please note in-fill grindings mound will be left above ground level to allow for settling
