Further to the purchase of this site Gavacan Homes seek amendments to Plots 1 and 2 to meet the requirements of the purchasers of these dwellings.

The dwellings have been amended to allow attic accommodation, an amendment to the design of the dormer on plot 2, and increases in size to the rear single storey garden rooms, and the installation of PV panels on the roofs. Skylights are limited to the rear elevations. While there is a marginal increase in ridge height, this is partially compensated by a lowering of the finished floor levels of plots 1 and 2.

The ridge height of plot 2 will be 2.04m lower than the ridge height of Green End.

The flank elevations retain the detailing and articulation of the approved scheme and there will be no impact on the on the heritage setting of Green End or neighbouring dwellings and no loss of amenities.
