it is purposed to build a perimeter wall in front of 255 Coldharbour Lane. The front face of the perimeter length is in total 1128 cm and height is estimated at 183 cm. There will be an automated sliding steel gate with a pedestrian gate. The gate should also be the same height as the wall.

The front face of the wall is along Coldharbour Lane with a public pedestrian footpath just in front of the perimeter wall. There is an existing wall of 91cm already but has been partially knocked down by members of the public sometime at night a few months ago. More than that I have been suffering from litter being thrown into the compound by the public. Since the wall is low, empty cans, and bottles are also left on top of the wall, At the beginning of the Covid 19 pandemic, somebody had left a dead cat in my compound by the internal gate, This has been reported to the police too. We are from Nepal so I assume that we might be Chinese and we eat all sorts of animals. Therefore, to intimidate us, somebody should have thrown this dead cat in my compound.

To protect my family and maintain our privacy it is very essential to build a front-face perimeter wall to this height. Therefore, a planning permission request is submitted for your kind approval.
