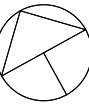

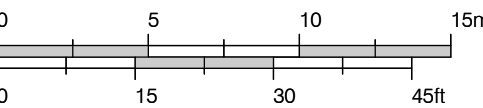
EXTERNAL FACADE MATERIALS

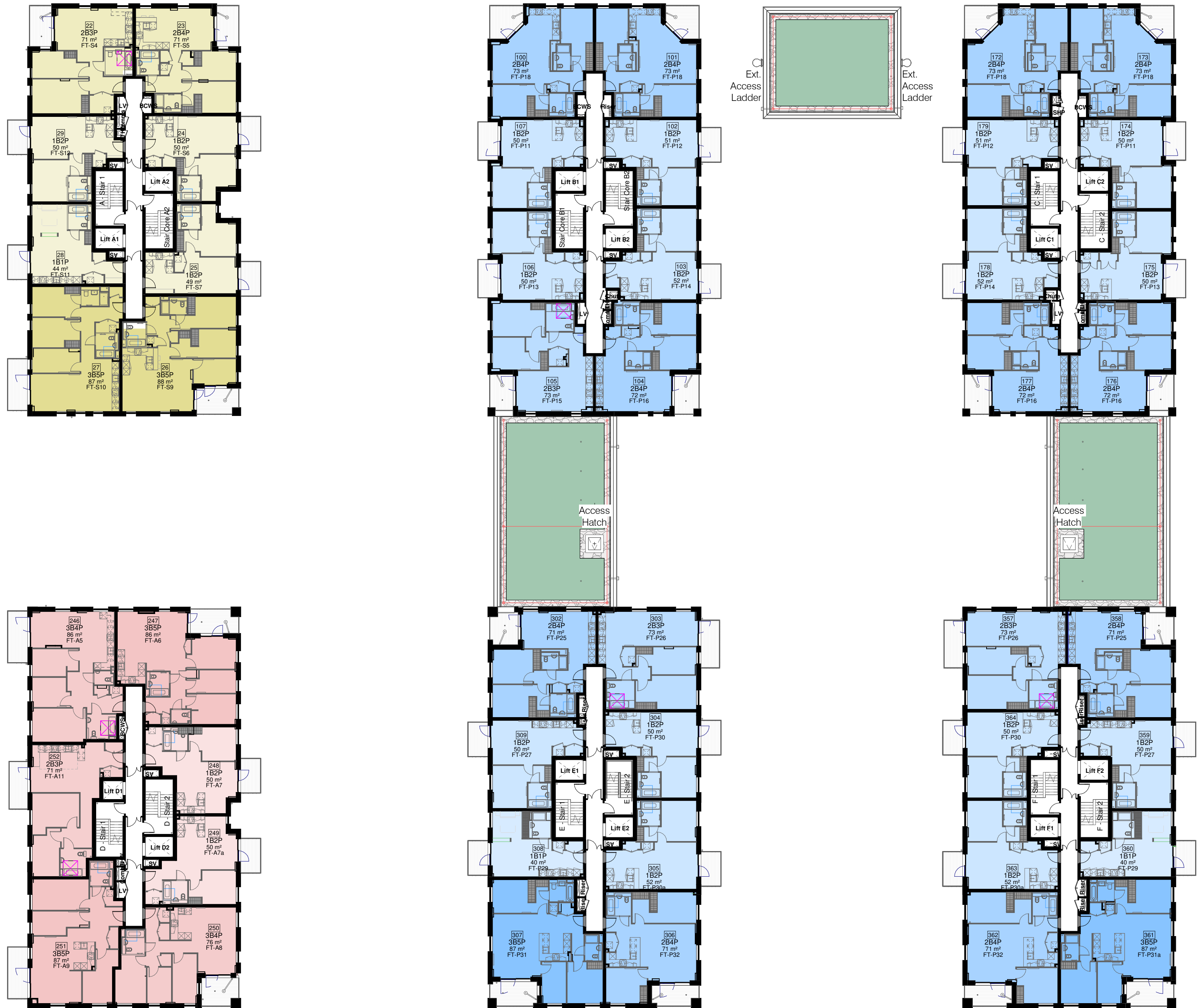
