I think if it is a joint project that the architectural “whole” should have cohesion and interest/quality-and glass is always beneficial to that in my opinion but I would agree with your analysis that this option has the best chance of success:-

Given the orientation solar gain shouldn't be too bad (other than at this time of year) and a sedum roof wouldn't harm the submission but they are a little bit tricky to police when it comes to implementation.

It is noted that Number 89 (= adjacent neighbour) have had a significant side/rear extension.
