Prior to this new 2026 application we had Hillingdon Planning Permission granted in 2022 and in 2021. We initially wanted to modify the approved plan (08/04/2021) as shown on drawing 22-AR-1. The proposal was to change the new kitchen length from 3.6m to 3.86m to build on rear existing boundary wall (to match the boundary line of the existing wall). Mrs Kinli advised we need to submit a new application with drawings. This was done and the new 2022 plan was granted. As the 3 year expiry for this had lapsed, we are submitting the same granted plan in 2022 now.
