Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The existing use of the courtyard by the hotel is a license restaurant, and is be serviced by the main restaurant kitchen. The proposal is an additional bar servery with pizza oven to assist with busy periods of service in the main kitchen.

The bar pizza oven hut is timber construction and easily demolished/removed in the future, and located more than 3 meters away from the boundary.

Additionally, we propose to erect a pergola/canopy for shading and a timber clad storage container to allow the hotel to store all the outdoor furniture.

Our new elements are in the back of the building. The existing building is not a listed building. Our alterations do not exceed 50% of the total area of land around the original.

These new elements are not themselves separated; they depend on the existing bar and they don't count with a microwave antenna.

Also, the eaves' height is less than 2.5m; the overall height does not reach 4m.

The separation for the property boundary is a minimum of 3 meters.
