### **FOOTPATH U81, THE GREENWAY** **STOPPING UP OF FOOTPATH U81 ORDER 2024**

THIS ORDER is made by the London Borough of Hillingdon under section 257 of the Town and Country Planning Act 1990 ("the Act") because it is satisfied that it is necessary to stop up the Footpath to which this Order relates in order to enable development to be carried out in accordance with the deemed planning permission granted under Section 20 of the High Speed Rail (London - West Midlands) Act 2017.

#### **BY THIS ORDER:**

- 1 The footpath over the land shown by a black line on the attached Plan and described the Schedule to this Order shall be stopped up as provided below.
- 2 Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any part of the footpath authorised to be stopped up pursuant to this Order then, for the purpose of carrying out their undertaking, the statutory undertakers shall continue to have the same rights in respect of the apparatus as they then had.

## **THE SCHEDULE**

### **DESCRIPTION OF FOOTPATH TO BE STOPPED UP**

A section of the footpath known as U81 that crosses the Chiltern Line Railway via a subway and runs in a northwest and northeast direction for an overall length of 190m from a point off The Greenway (TQ 08001 86916 and TQ08010 86914.) The section of U81 to be stopped up is divided into two parts. The first part runs 60m in a northwest direction from point A referenced on the Plan attached to the Order. The second part of U81 turns to a northeast direction and runs 130m underground as a subway to point B referenced on the Plan attached to the Order.

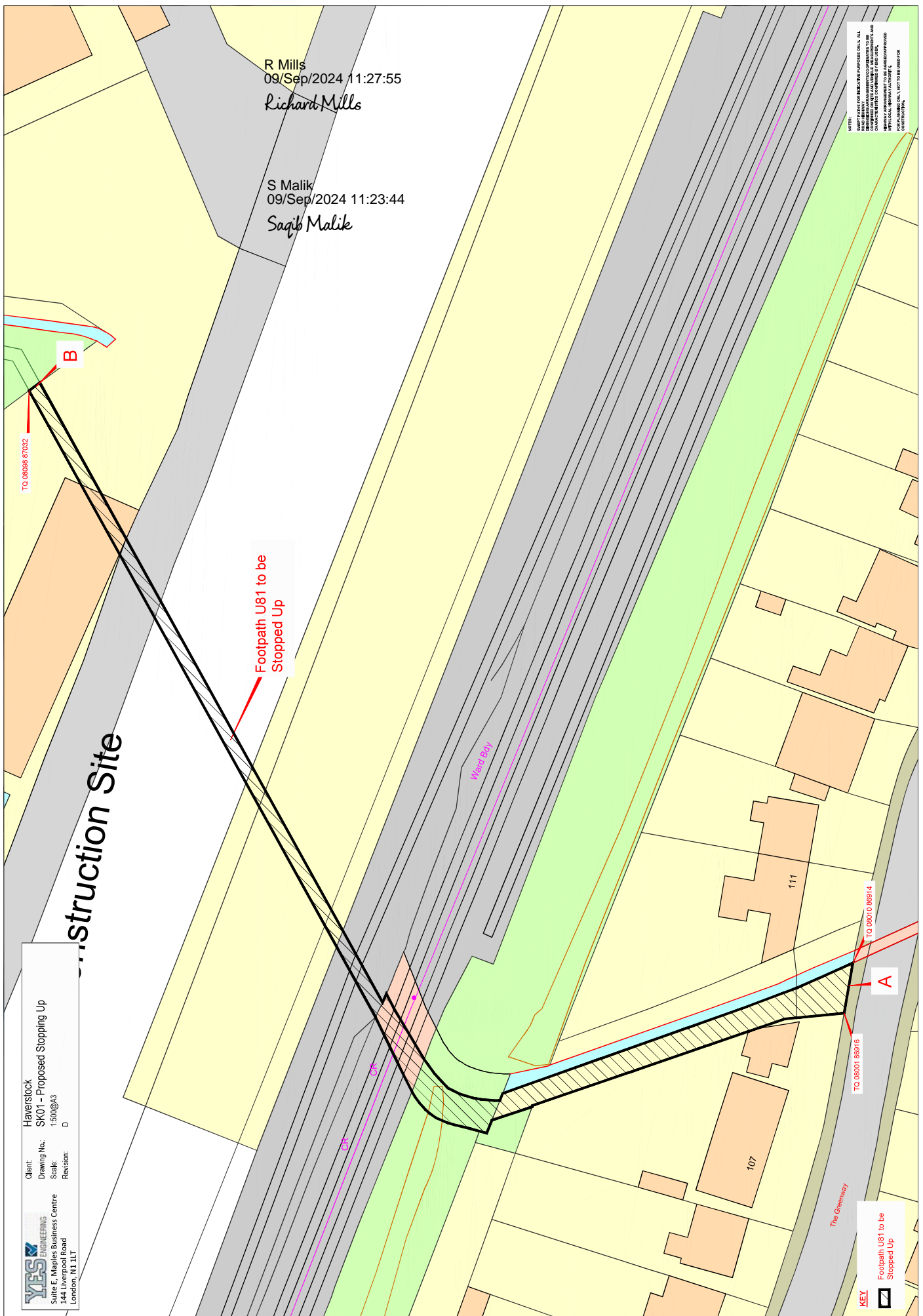
