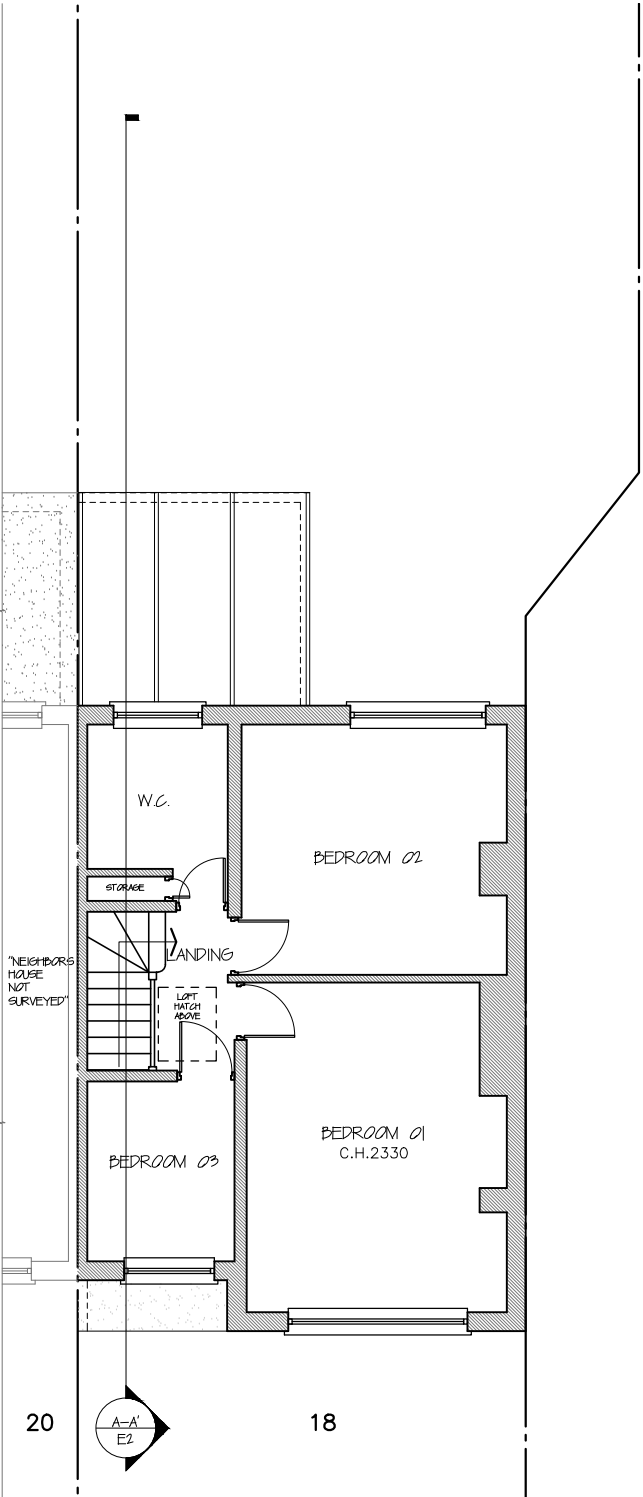
Existing Ground Floor Plan

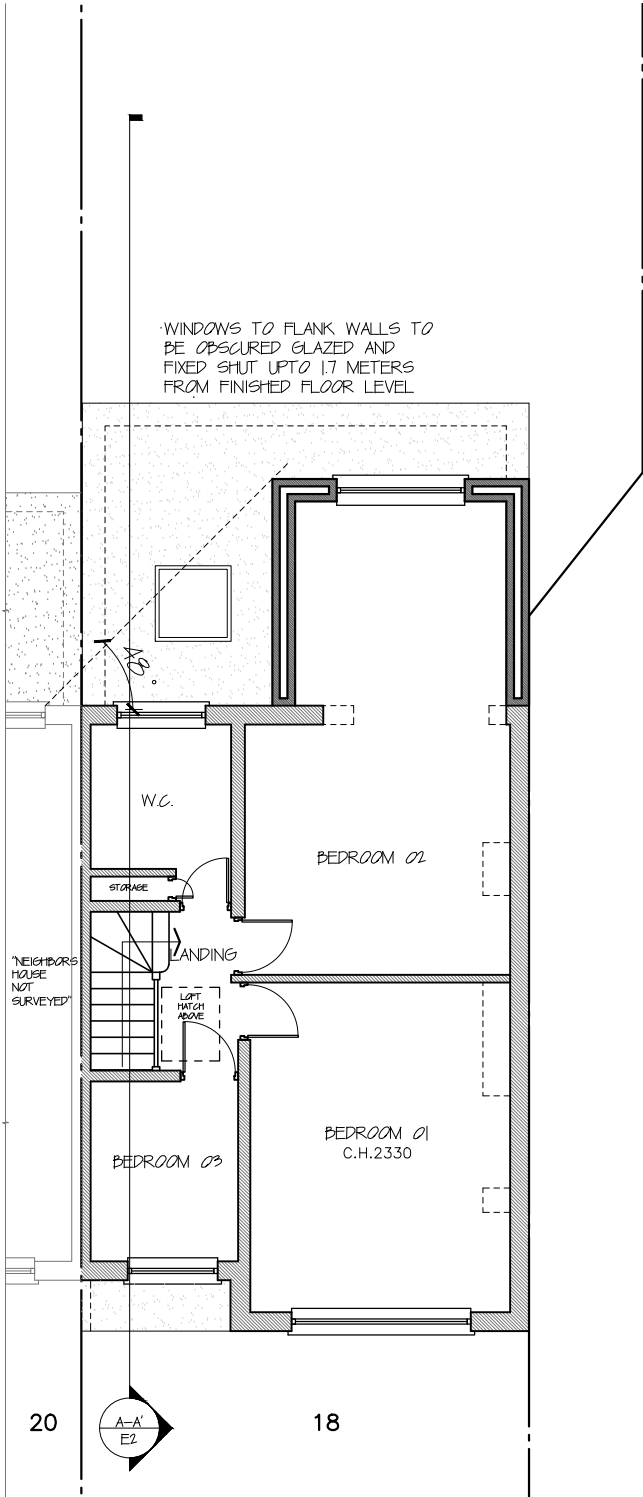
Proposed Ground Floor Plan
