As Bryony Close was not located in the wards where Article 4 was active pre Dec 25 no planning or license was acquired for the property. I attach 3 tenancy agreements dating before the change, bank statement where 3 rents have been paid and a signed declaration from the agents that confirm the tenants and dates of tenancies.

Given the expansion of Article 4 only took effect in Dec 25 to include all wards in Hillingdon the certificate should be granted. The property consists of 3 large bedrooms, parking for 2 vehicles and a large rear garden providing excellent living accommodation for the tenants. Given the rooms and facilities are considerably larger than those required by HMO standards the certificate should be granted.
