Details of the pre-application advice received

1. Planning permission no listed building consent as its not touching the building.
 2. As discussed at the time it would be preferred that a comprehensive in keeping fencing and brick walling scheme be designed to prevent access to the overall site in keeping with the character of the building.
- However clearly we don't want the building to be burnt down in the meantime whether accidentally or on purpose. The fencing would need planning permission. Recommend applying for say either 3 or 5 year consent to allow you time to design, get permission for and fundraise a permanent in keeping security solution. In the mean time generally we would be supportive given the issues and the proposed design. We can't tell you that you would be granted planning permission as that needs to go through the process but we would aim to respond quickly and positively to safeguard the future of the building.
- Once we have the application it might be worth emailing to discuss as we can perhaps give an informal steer and suggest if consent would be granted which could allow manufacture of the fence and gate to begin during the application process and prevent any unnecessary delays.
