Details of the pre-application advice received

An email was sent to the general 'planning@hillingdon.gov.uk' email address, inquiring about the following issues;

- if the proposed extension length and proposed roof pitched looked suitable
- whether or not a Party Wall Agreement needed to be in place in order to submit a Planning application
- to check what sort of Planning application needed to be submitted

In response, it was communicated that;

- it would be difficult to substantiate significantly harmful amenity impacts as a result of the proposed development, based on the Sketches provided
- that the height of the roof should not exceed 3.4m in height (as per design guide)
- that the absence of a Party Wall Agreement would have no bearing on the outcome of the Planning application
- that a Householder application was required
