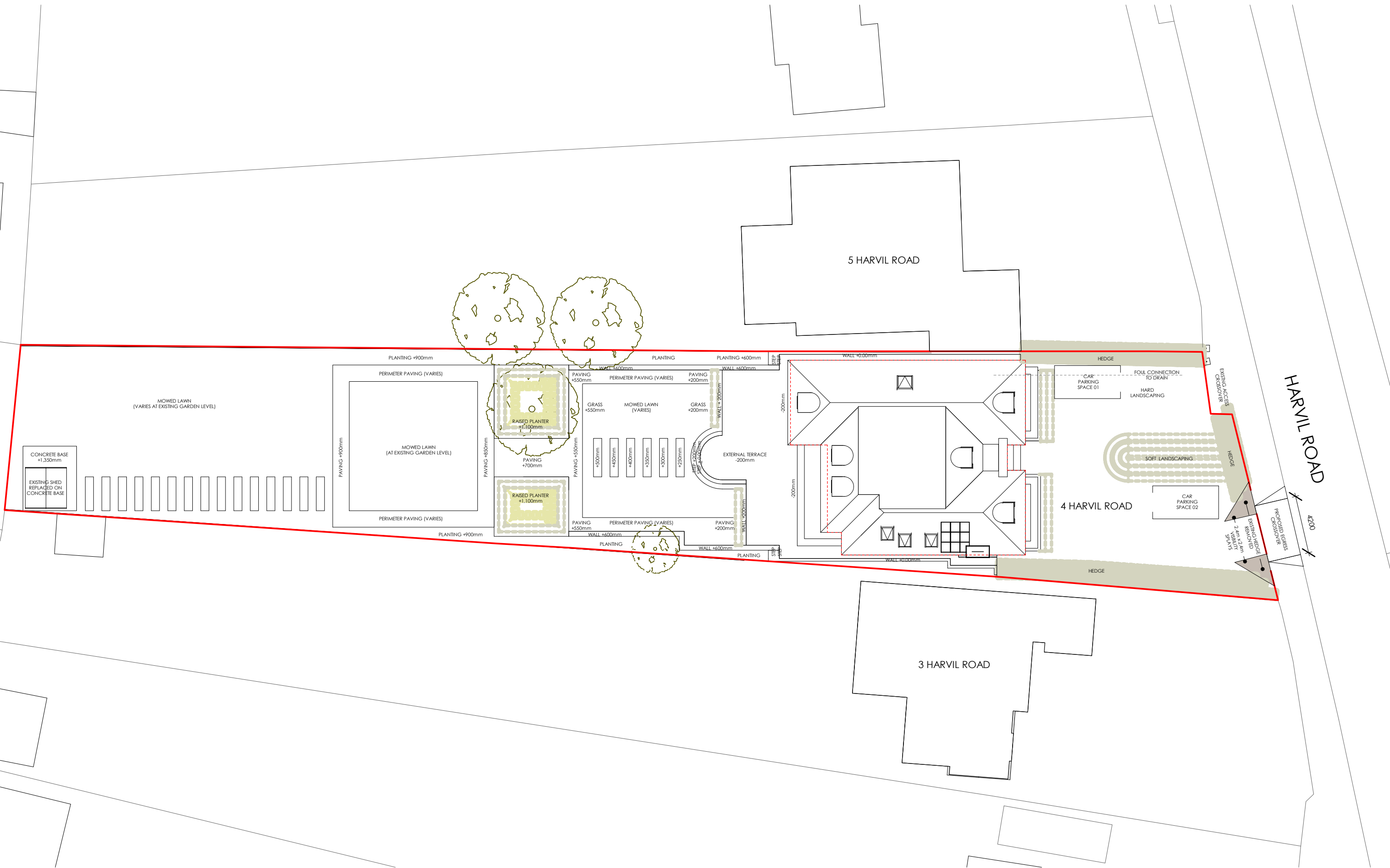

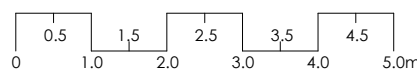

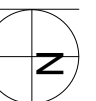

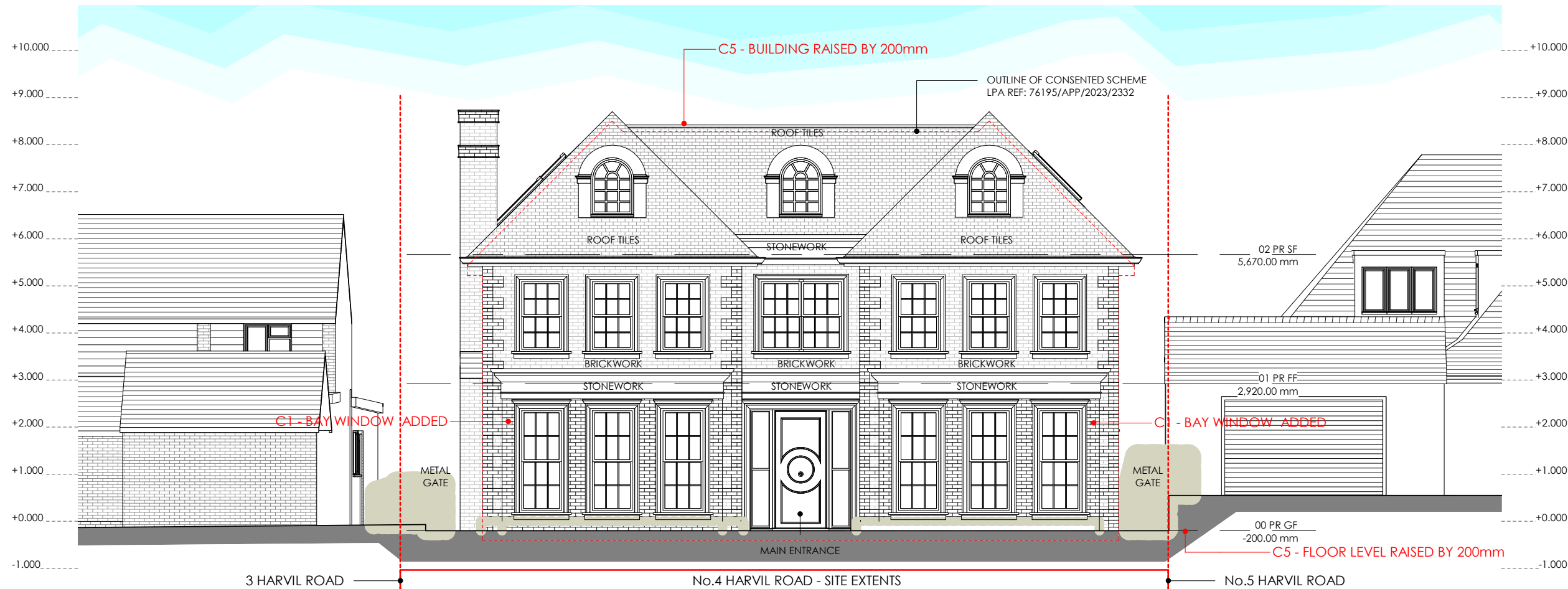
C354-13 Proposed First and Second Floor Plans (Rev C)

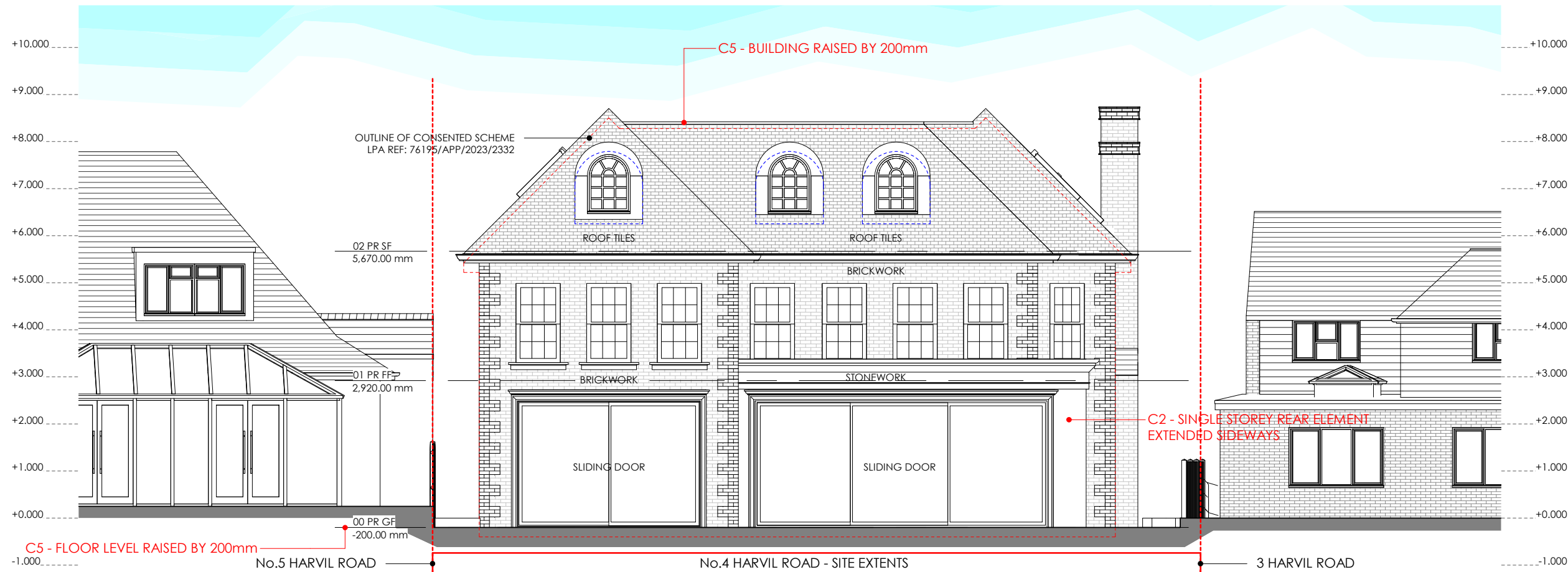

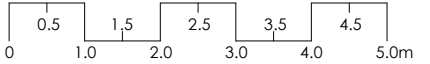

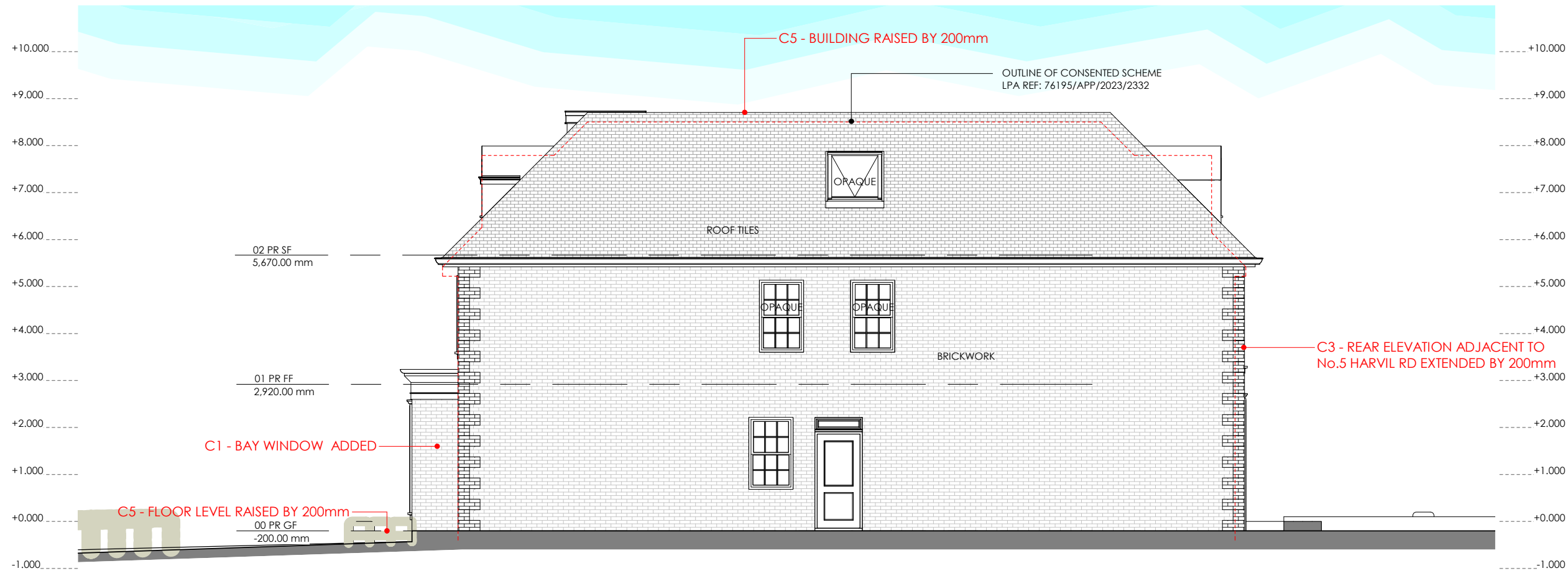

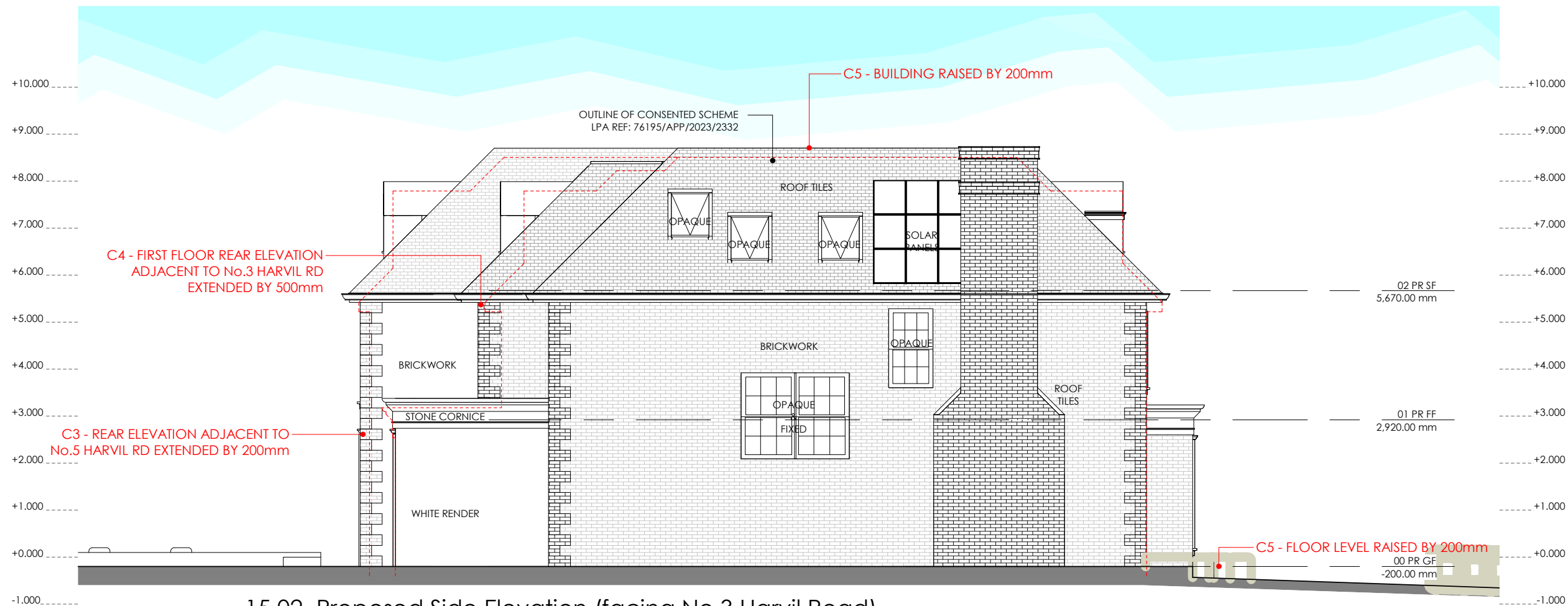

15.01 Proposed Side Elevation (facing No.5 Harvil Road)



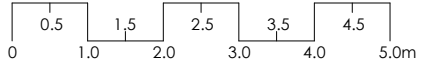
15.02 Proposed Side Elevation (facing No.3 Harvil Road)

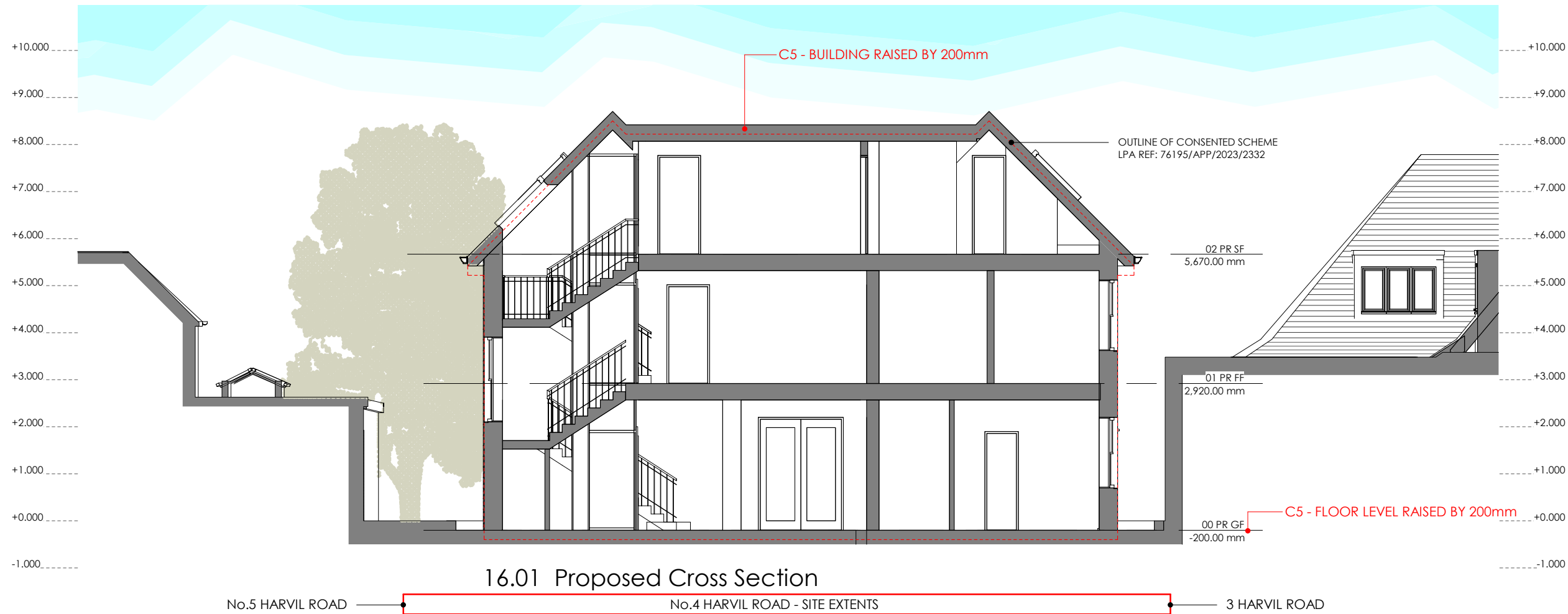

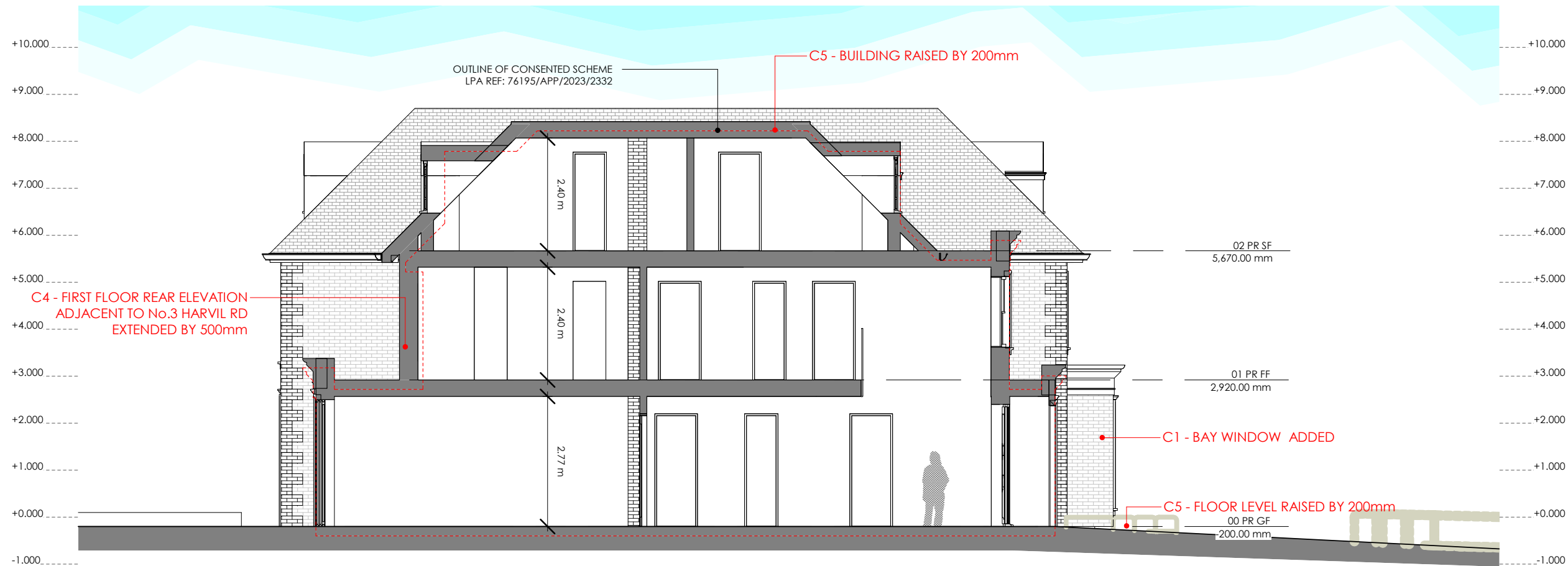

16.01 Proposed Cross Section



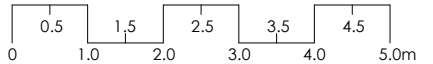
16.02 Proposed Long Section Through Entrance Hall

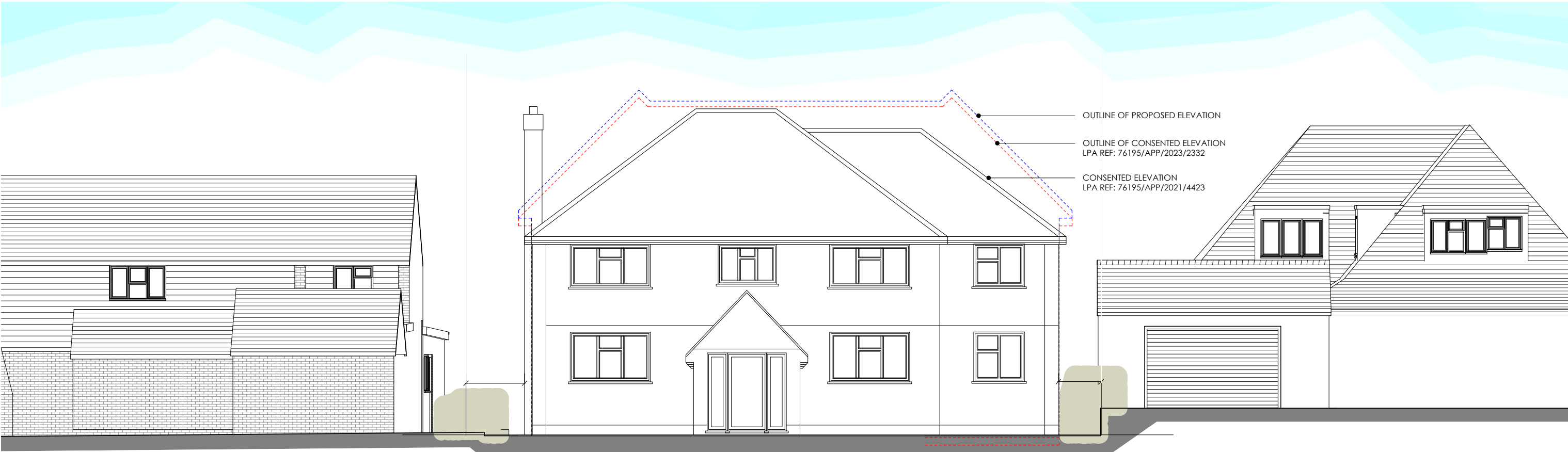
