Details of the pre-application advice received

There is no in principle objection to the proposed side extension which would utilise the footprint of the existing garage. However, we would like to emphasise the proposed extension must be set back from the front and back by at least 1m and should not exceed half the width of the existing house. Furthermore, the windows should be positioned centrally on the elevation to match that of the existing house. As I explained on the phone, I have no objections to the insertion of rooflights. In terms of the proposed balcony at first floor level, given there is already a balcony, I have no objection to its inclusion.
