The applicant has complied with the first part of the condition in using Plikingtons Optifloat Glass which has a Privacy Level of 5. Which is the highest they make to ensure full privacy is maintained.

The two windows in question are in non habitable rooms namely bathrooms. As Bathrooms these rooms are subject to high levels of moisture and steam and whilst they have electrical extract fans linked to the lighting the rooms would greatly benefit from some natural ventilation by restricted opening fixtures which the applicant proposes to fit and maintain. These child lock / restricters would allow natural ventilation but would ensure nobody could look out of the windows. We attach details of the proposed fixtures.
