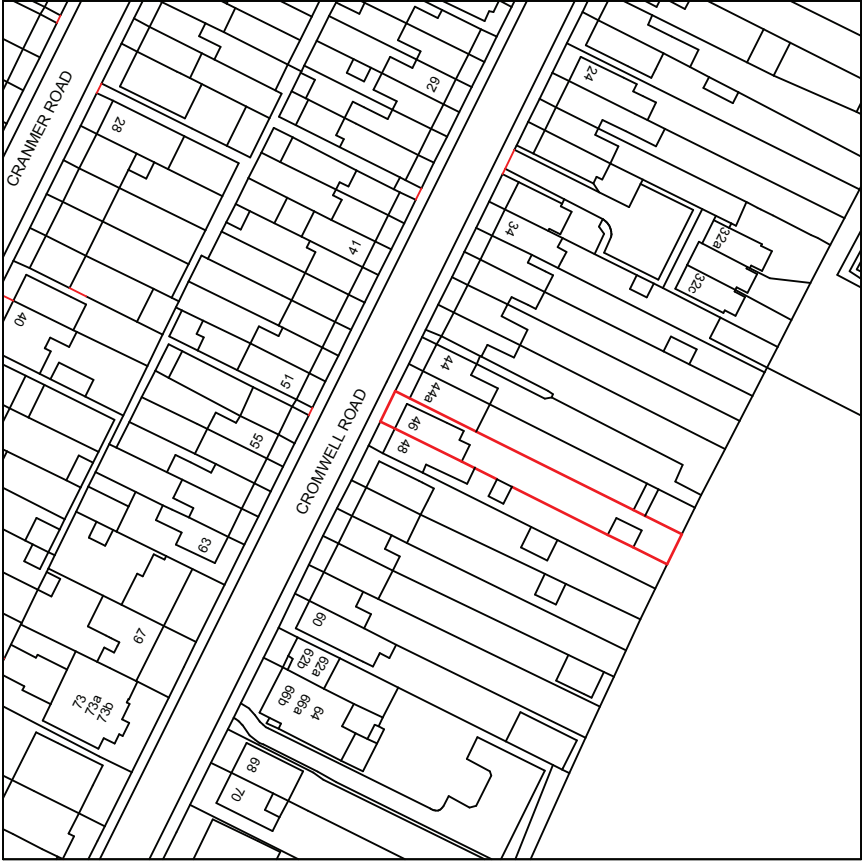
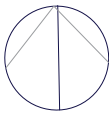


LOCATION PLAN - 00.01

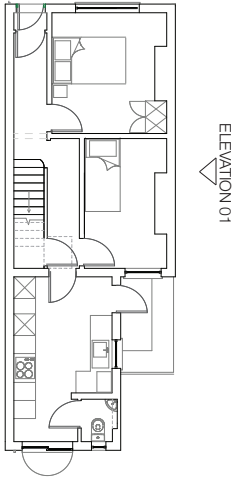
