TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED)

RE: Application for a Certificate of Lawfulness for Use of a single dwellinghouse
(Use Class C3) as a House in Multiple Occupation (HMO) (Use Class C4)

AT: 121 Adelphi Crescent, Hayes, Middlesex UB4 8NA

I write on behalf of the applicant to submit an application for a Certificate of Lawfulness for an Existing Use pursuant to Section 191 of the Town and Country Planning Act 1990 (as amended).

This application is made on behalf of Mr Glenn Bolding in respect of the property at 121 Adelphi Crescent, Hayes. The application seeks confirmation that the use of the property as a small House in Multiple Occupation (Class C4) was lawfully established prior to the introduction of the London Borough of Hillingdon's borough-wide Article 4 Direction withdrawing permitted development rights for the change of use from a dwellinghouse (Class C3) to a small HMO (Class C4). This statement is supported by the evidence appended at Appendices 1 to 6, which demonstrates that the use of the property as a small HMO (Class C4) commenced no later than 8 October 2024, in advance of the date on which the borough-wide Article 4 Direction came into force on 11 December 2025.

THE SITE

The application site comprises a dwellinghouse located at 121 Adelphi Crescent,

Hayes, within the London Borough of Hillingdon. The property is situated within an established suburban residential area characterised by similar dwellinghouses. A full description of the site and its surroundings will be included in the supplementary evidence to be submitted in support of this application.

PLANNING HISTORY

There is no recent planning history on the Council's public planning register that is material to the determination of this application.

THE PROPOSAL

This application seeks a Certificate of Lawfulness for the existing use of the property as a small House in Multiple Occupation (HMO) falling within Use Class C4 of the Town and Country Planning (Use Classes) Order 1987 (as amended).

A small HMO (Class C4) is defined as a property occupied by between three and six unrelated individuals who share basic amenities such as a kitchen or bathroom, and where the property is their only or main residence.

THE ARTICLE 4 DIRECTION

The London Borough of Hillingdon has adopted a borough-wide Article 4 Direction under Article 4(1) of the Town and Country Planning (General Permitted Development) (England) Order 2015, which withdraws the permitted development right under Class L of Part 3 of Schedule 2 of the GPDO to change use from a dwellinghouse (Class C3) to a small House in Multiple Occupation (Class C4) across the entire administrative area of the borough.

The article 4 direction came into force on 11 December 2025. From the date the Direction came into force, the change of use from Class C3 to Class C4 within the borough has required express planning permission.

Critically, any property that was already lawfully in use as a small HMO (Class C4) before the Article 4 Direction came into force remains lawful, as the change

of use would have taken place at a time when it constituted permitted development under Class L of Part 3 of Schedule 2 of the GPDO. No planning permission was required at that time.

LEGAL FRAMEWORK

Section 191 of the Town and Country Planning Act 1990 (as amended) provides that if any person wishes to ascertain whether any existing use of buildings or other land is lawful, they may apply to the local planning authority for a certificate of lawfulness of existing use or development.

Section 191(2) states that uses and operations are lawful at any time if no enforcement action may then be taken in respect of them, or if they could not constitute a breach of planning control.

The burden of proof lies with the applicant to demonstrate, on the balance of probabilities, that the use was lawfully established prior to the Article 4 Direction coming into effect. The test, as established in *F.W. Gabbitas v Secretary of State for the Environment* [1985] JPL 630, is whether the evidence is sufficiently precise and unambiguous to justify the grant of a certificate on the balance of probability.

THE EVIDENCE

This statement is supported by the following evidence, appended at Appendices 1 to 6, which has been reviewed by this office and which, taken together, demonstrates on the balance of probabilities that the use of the property as a small HMO (Class C4) commenced no later than 8 October 2024, well in advance of the date on which the borough-wide Article 4 Direction came into force on 11 December 2025:

- Appendix 1 – Bank statements: Monzo bank statements for the applicant's personal account covering the period from October 2024 to June 2026 (in excess of 20 consecutive months), evidencing recurring monthly rental receipts from multiple unrelated individuals, including Mr Akhil Vasudevan (payments referenced "RENT" received from 8 October 2024 onwards), Ms Deekshya Chudali (payments referenced "RENT" received from 2 December 2024

onwards, together with a rent deposit received on 12 December 2024), and a further occupier identified in the statements as "Katie", whose monthly payments (referenced "KATIE 1 MONTH RENT") are recorded from 9 October 2024 onwards;

- Appendix 2 – Excluded tenancy agreements: between the applicant and (i) Mr Akhil Vasudevan and Ms Baljeet Kaur, signed on 8 October 2024 and countersigned by the applicant on 12 November 2024, and (ii) Ms Deekshya Chudali and Mr Pratik Timsina, countersigned by the applicant on 12 December 2024 and signed on 2 January 2025. Each agreement confirms the letting of an individual double bedroom at the property, with shared use of the hallway, stairs, landing, bathroom, lounge, kitchen and garden, and records payment of a rent deposit;
- Appendix 3 – Rental payment records: screenshots of Monzo payment notifications confirming receipt of a rent deposit from Ms Deekshya Chudali on 12 December 2024, and confirming continuing monthly rent payments from Ms Chudali through March 2025, April 2025, June 2025, August 2025, February 2026 and March 2026, corroborating the continuity of the HMO use both before and after the Article 4 Direction came into force;
- Appendix 4 – Third-party delivery and order records: order confirmations addressed to Mr Akhil Vasudevan at 121 Adelphi Crescent, Hayes, UB4 8NA, including a Sainsbury's order confirmation dated 8 May 2025, an Amazon order delivered on 17 January 2026, and a further Sainsbury's receipt dated 26 May 2026, each confirming continuous residence at the property by the same named occupier throughout the relevant period. All of the orders relate to cat food, for the cat called Obi, mentioned in the tenancy agreements and
- Appendix 5 – Tenant identification: copies of the passports of Mr Pratik Timsina and Ms Deekshya Chudali, confirming that the occupiers of the property were unrelated individuals.
- Appendix 6 – Statement of Truth from the applicant.

ANALYSIS

The evidence set out above demonstrates, on the balance of probabilities, that the property at 121 Adelphi Crescent, Hayes was converted from a single family

dwellinghouse (Class C3) into a small House in Multiple Occupation (Class C4), and that this use was lawfully established prior to the date on which the borough-wide Article 4 Direction came into force.

Taken in the round, the evidence:

1. Confirms the date upon which the use of the property as a small HMO (Class C4) commenced, being no later than 8 October 2024, by reference to the excluded tenancy agreement signed by Mr Akhil Vasudevan and Ms Baljeet Kaur on that date (Appendix 2), and corroborated by the corresponding rental payments recorded in the applicant's bank statements from 8 October 2024 (Appendix 1);
2. Confirms that the occupiers of the property – Mr Akhil Vasudevan, Ms Baljeet Kaur, Ms Deekshya Chudali, Mr Pratik Timsina, and a further occupier identified as "Katie" – were unrelated individuals occupying individual bedrooms within the property as their only or main residence, and sharing basic amenities including the kitchen, bathroom and lounge (Appendices 2 and 5);
3. Provides contemporaneous documentary corroboration of the date on which the HMO use commenced and of the continuity of that use through to the date of this application, by reference to the signed tenancy agreements (Appendix 2), the deposit and rent payments recorded in the applicant's bank statements and payment screenshots (Appendices 1 and 3), and third-party delivery records addressed to an occupier at the property as recently as May 2026 (Appendix 4);
4. Demonstrates that the date on which the HMO use commenced, no later than 8 October 2024, predates by over fourteen months the date on which the borough-wide Article 4 Direction came into force on 11 December 2025; and
5. Is sufficiently precise and unambiguous to satisfy the test for the grant of a certificate of lawfulness on the balance of probabilities (per *F.W. Gabbitts v Secretary of State for the Environment* [1985] JPL 630), given the consistency between the signed tenancy agreements, the contemporaneous bank statements, and the independent third-party delivery records addressed to occupiers at the property.

At the time the HMO use commenced, in October 2024, the change of use from a single family dwellinghouse (Class C3) to a small HMO (Class C4) was

permitted development under Class L of Part 3 of Schedule 2 to the Town and Country Planning (General Permitted Development) (England) Order 2015. No planning permission was therefore required at that time.

As the use was lawfully established before the borough-wide Article 4 Direction came into effect, and has continued without material interruption from October 2024 to the date of this statement, the use remains lawful and no planning permission is required for its continuation.

CONCLUSION

The case advanced on behalf of the applicant is that the property at 121 Adelphi Crescent, Hayes, Middlesex UB4 8NA was converted from a single family dwellinghouse (Class C3) into a small House in Multiple Occupation (Class C4) by no later than 8 October 2024, which is prior to the date on which the London Borough of Hillingdon's borough-wide Article 4 Direction came into force on 11 December 2025, and that the use was lawfully established and has continued without interruption since that time.

At the time the HMO use commenced, the change of use from Class C3 to Class C4 was permitted development under Class L of Part 3 of Schedule 2 of the GPDO and required no planning permission. The use therefore remains lawful and no planning permission is required for its continuation.

On the basis of the evidence appended at Appendices 1 to 6, the Council is respectfully requested to issue a Certificate of Lawfulness under Section 191 of the Town and Country Planning Act 1990 (as amended) confirming the lawful use of the property as a small HMO (Class C4).

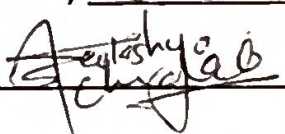

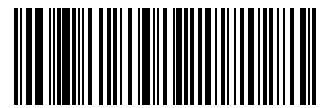
