Development authorised by the High Speed Rail (London-West Midlands) Act 2017 relating to the Harvil Road Realignment Works. The proposed development covering a site area of 46,528.5m2 is for the realignment of approx. 1km of Harvil Road, including the Harvil Road Stream Underbridge (comprising wingwalls, parapets, box culvert and mammal ledge); earthworks associated with the highway embankments, access roads to the realigned Harvil Road, and the location of vehicle restraint systems and fencing. Building works associated with the concrete weir and non-woven geotextile bags at the attenuation pond. Earthworks associated with the attenuation pond area comprising swales, gabion baskets, access road, pedestrian access track, an attenuation pond; and the location of fencing.
