Equating to a total of 33.74 cubic meters extension, within the allocated 40 cubic meters for a semi-detached house. The proposed front extension equates to a total of 1.84sqm, within the allocated 3sqm allocation. The proposed ground floor rear extension covers all the required design regulations and allocations for lawful development such as size and total garden usage.
