Land at Austin Road, Hayes- Response to Comments Received on Application ref: 76550/APP/2022/3662


On behalf of our client, Higgins Partnerships 1961 PLC (“Higgins Homes”), please find enclosed an updated Design and Access Statement and Proposed Drawing set in relation to the Non-Material Amendment (NMA) application reference 76550/APP/2022/3662. This NMA relates to phase 1 of the development covered by planning permission 76550/APP/2021/4499.

In addition to the proposed changes set out in the first covering letter dated 2 December 2022, the following changes have been made to the proposed drawings:

- 1 In response to your comments, the proposed parapet height has been reduced in height so that the highest point of the building is now slightly lower than in the consented scheme. This change is explained on page 21 of the updated Design and Access Statement and is reflected in the proposed drawings.
- 2 In response to changes in fire safety building regulations, changes are proposed to the core arrangement, lift size and window specification. As a result of these changes, small adjustments to the layout of apartments located closest to the core have also been made. These changes are shown on p. 15 and 27 of the DAS.

These changes are shown in the submitted revised drawings listed in Annex 1 which supersedes the drawings list appended to our covering letter dated 2 December. The Design and Access Statement (dated 09.02.23) has also been updated to reflect the changes.
