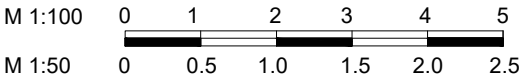

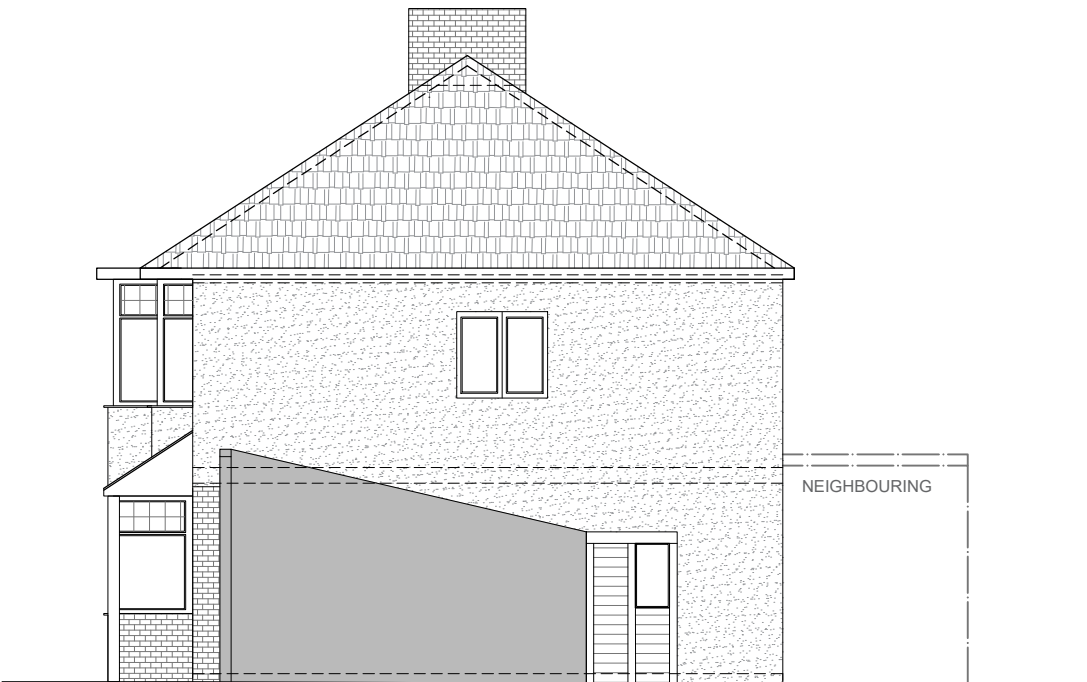

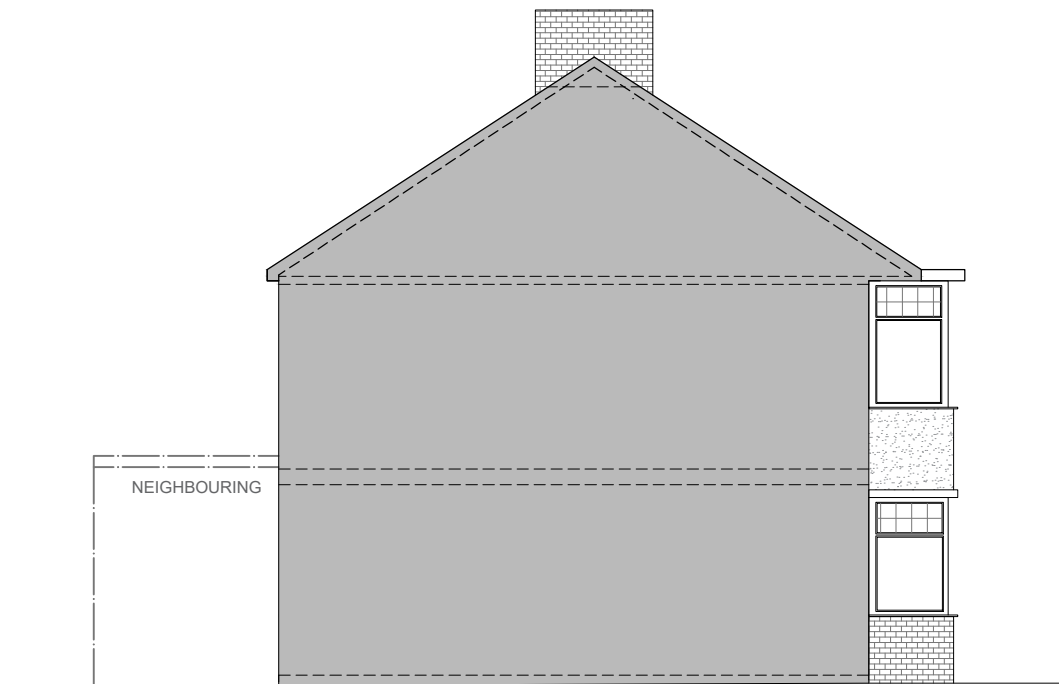
EXISTING FRONT ELEVATION



EXISTING RIGHT SIDE ELEVATION



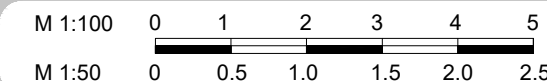
EXISTING REAR ELEVATION

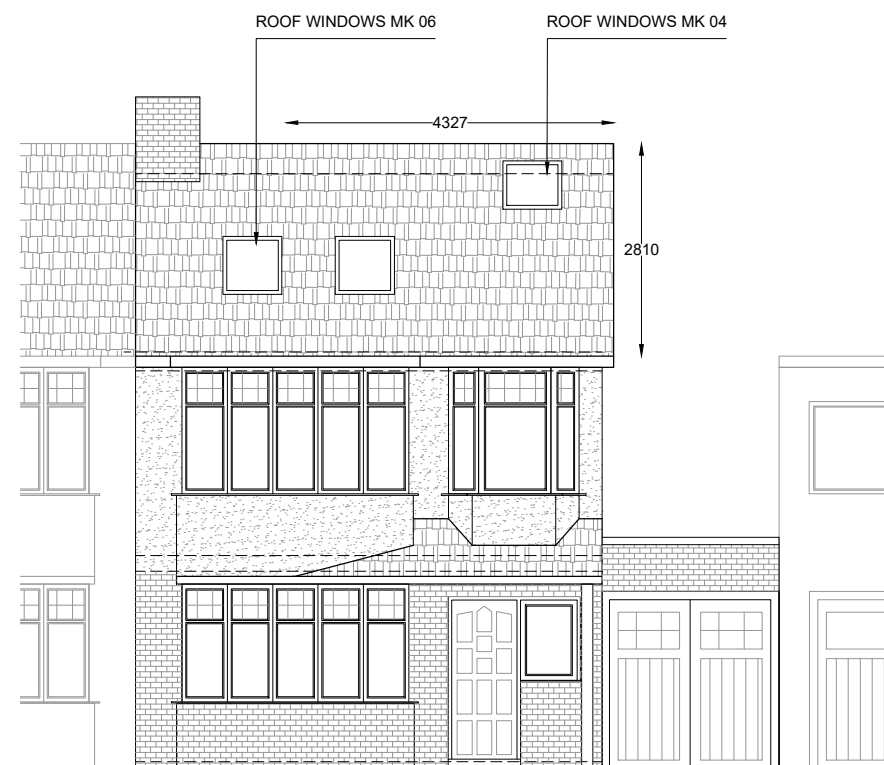

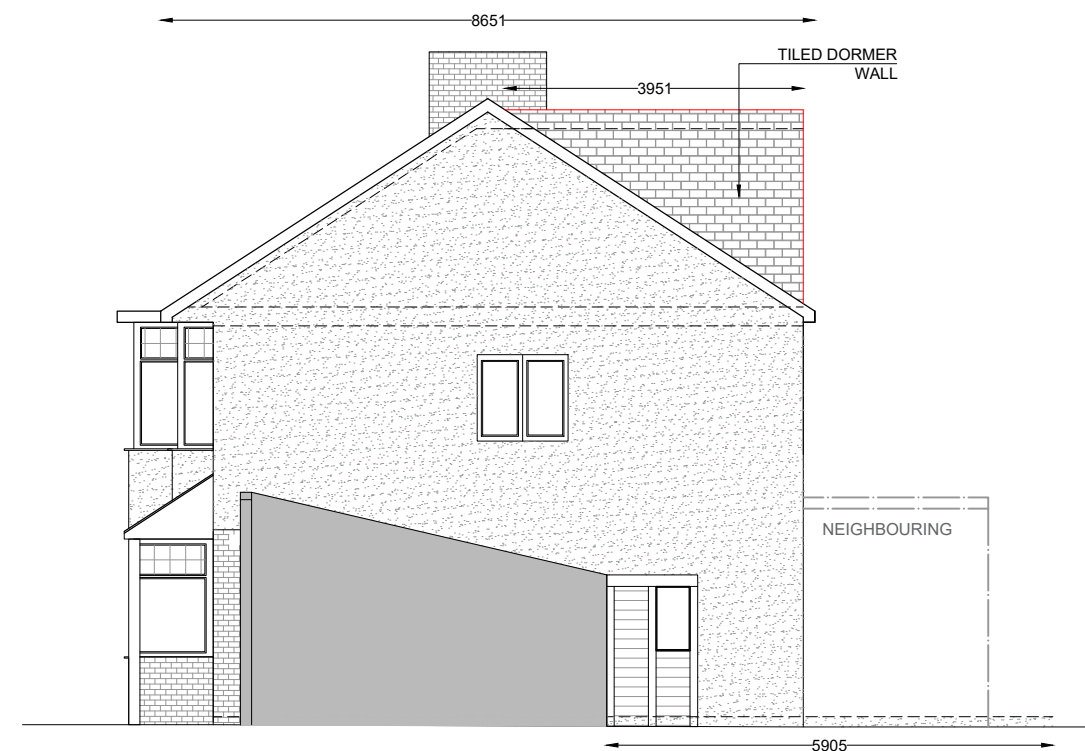

PROPOSED RIGHT SIDE ELEVATION

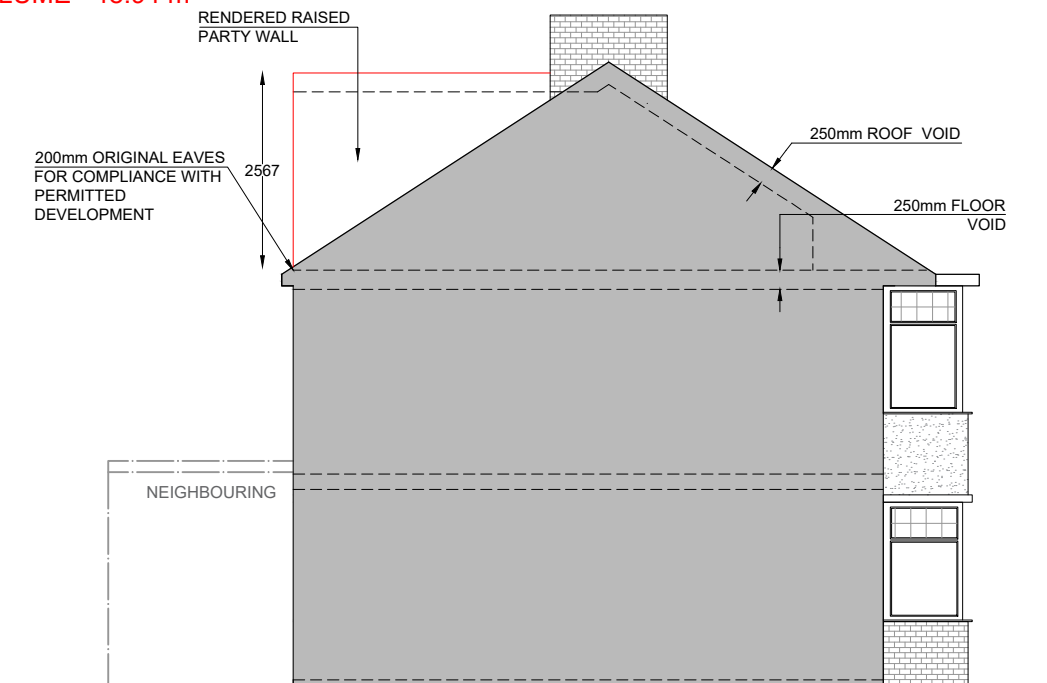
ROOF VOLUME CALCULATIONS

- HIP TO GABLE
 $4327 \times 8651 \times 2810 / 6 = 17.63 \text{ m}^3$

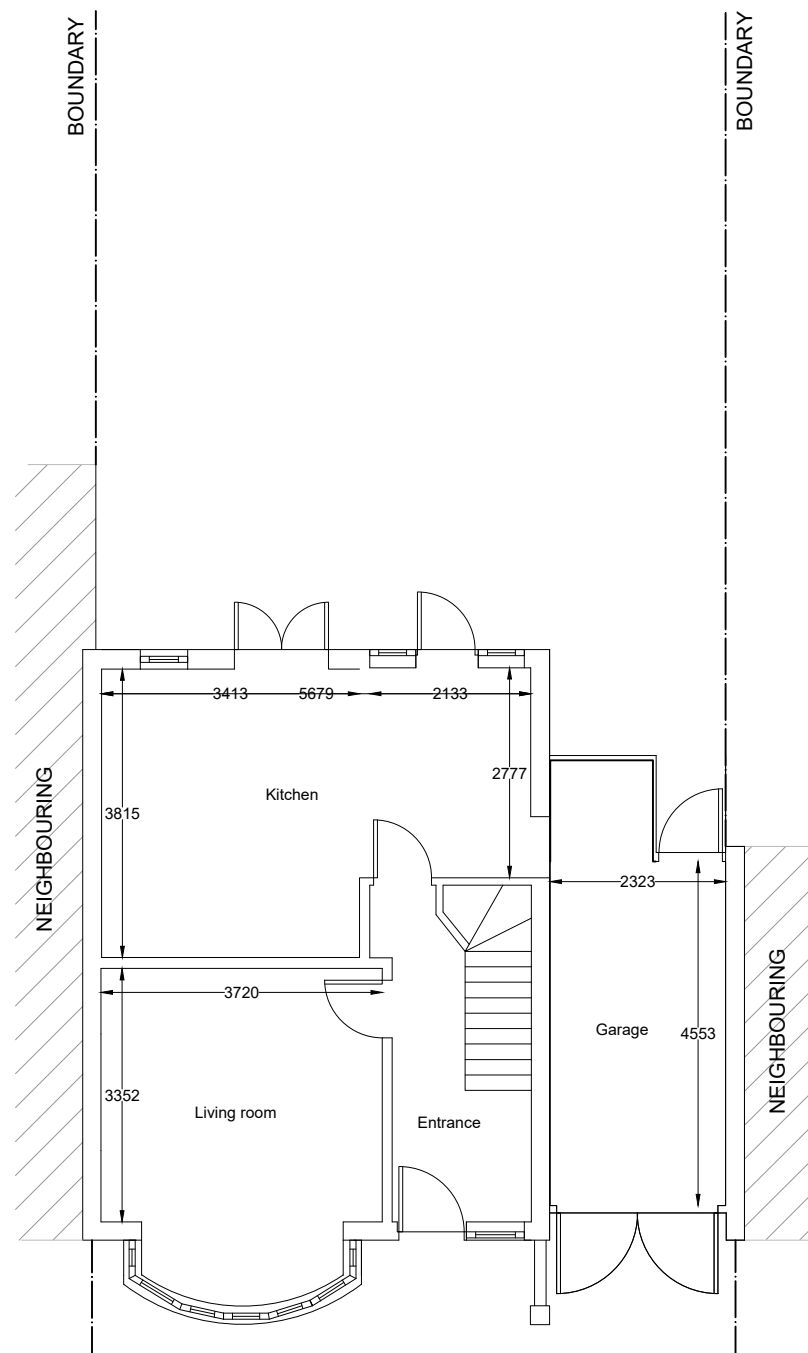

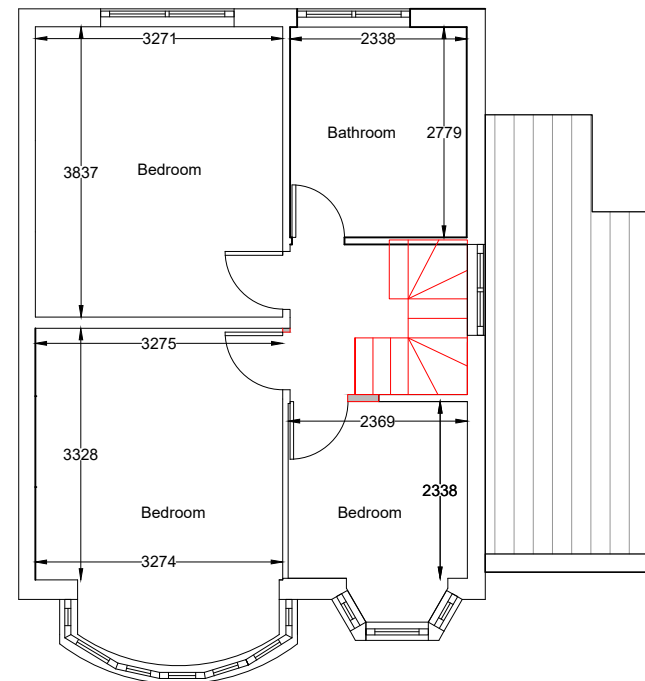

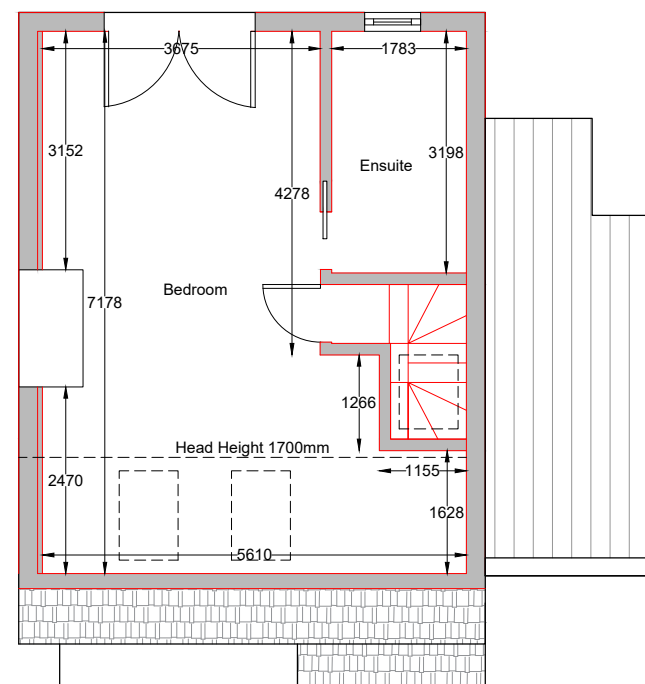

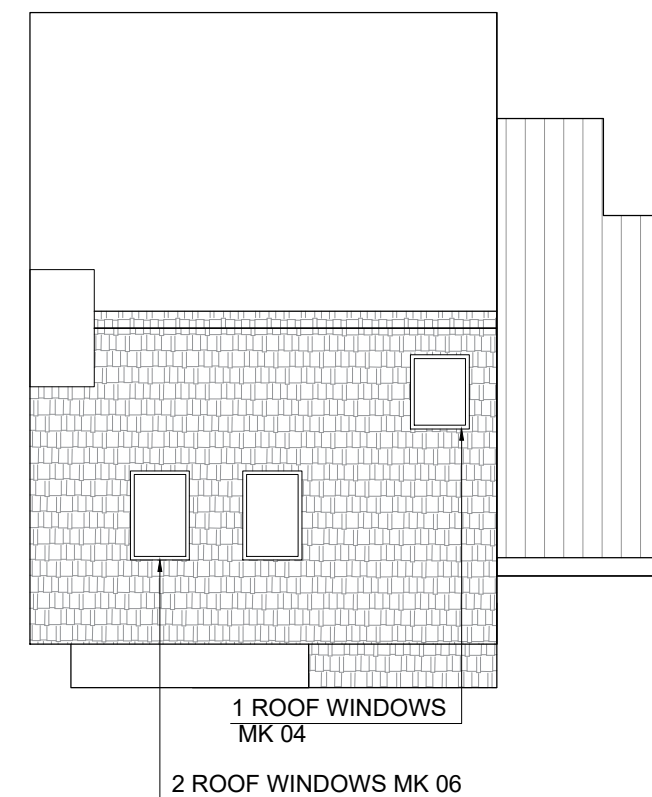
PROPOSED GROUND FLOOR PLAN
