Amendment of the triggers of conditions 17 and 19 to amend the trigger to 'prior to above ground works' instead of 'prior to commencement of development', and 'no development shall commence on site'. This is to allow the initial phase of the development to commence (enabling works etc.) prior to these additional details being developed. The amendment of the trigger will not prevent the requisite information being able to be provided and complied with, it will just allow the development to commence whilst further detailed design of the construction stage scheme is being worked up, so as to not unduly delay the development from commencing. The requirements of conditions 17 and 19 would not be affected by the proposed commencement of the enabling works and will be secured prior to the above ground works.
