The proposed development includes a total of 95 residential units across the two building with 100% being affordable housing.

The Yiewsley Library Site will have 100% affordable provision with 50 no. 1, 2- and 3-bedroom flats as Social Rent.

The Yiewsley Former Pool Site will have 100% affordable provision 45 no. 1, 2- and 3-bedroom flats as Social Rent.
