In any case however I note that a resubmission of a materially similar proposed would constitute a free resubmission. In the first instance, the reasons for refusal and accompanying officers report outline the areas of concern to be addressed. This was predominantly the depth of the extension and height especially at the neighbouring boundary which will be need to be reduced to align with the requirements set out within Policy DMHD1 of the Local Plan.
