The proposed planning application entails the construction of a temporary air conditioning plant. This plant will serve the purpose of providing temporary cooling or temperature control in a designated area. To address any potential visual impact, the air conditioning plant will be surrounded by intermittent plant screening.

The intermittent plant screening will consist of strategically placed vegetation, such as trees, shrubs, or other plants, aimed at partially concealing or camouflaging the air conditioning plant. This approach intends to harmonize the plant with its surroundings, minimizing its visual prominence within the landscape or in relation to nearby structures.

The intermittent plant screening surrounding the temporary air conditioning plant will be constructed using timber. Timber, a natural and sustainable material, will be utilized to create the screening structure. This choice of material ensures both functional and aesthetic objectives are met, as timber blends well with various landscapes and provides a visually pleasing appearance. Additionally, timber can be treated to enhance its durability and resistance to weathering, ensuring the longevity of the plant screening. The use of timber aligns with environmental considerations and contributes to a harmonious integration of the air conditioning plant within its surroundings.
