## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

G132: Swedish Whitebeam - fell infected tree to monolith at 4m.

Crown close to building, deadwood, low crown over path. Tree nearest the road (which we are applying to monolith) has multiple fungal infections on stem and crown. A large strip of dieback extends from the base of the tree, up the stem and into the crown.

T165: Ash – crown reduce by 3-4m to reduce wind loading.

Previously reduced. Several cavities on main stem with Inonotus in at least one cavity. Evidence of Ash dieback in crown.

T166: Ash – monolith down to approx. 6m from ground level.

Previously reduced. Huge Ganoderma bracket at base, approx. 50cm across, and the use of a sounding hammer indicated a large cavity behind. Inonotus bracket on main stem at approx. 8m. Evidence of extensive Ash dieback in crown. Some of the main stem is entirely dead.

T301: Horse Chestnut – fell to ground level.

Previously reduced, very small re-growth but unclear when tree was last pruned. Canker and leaf minor present. Two large cavities at main union from branch tearing, severely compromising at least one of the three main stems.

T338: Yew – crown reduce by 3-4m.

Large cavities at base and infected with Laetiporus fungus.

T341: Sycamore – pollard back to 3m past crown break (approx. 10m).

Previously heavily pollarded, large cavities at all pollard points. Long extended re-growth. Deadwood throughout crown. Huge rigidiporus brackets at base.

T350: Lime – repollard. epicormic removal.

Previously heavily pollarded, with cavities at old pollard points but unable to see extent of decay. Long extended re-growth overhanging busy road, pavement and private gardens and very narrow attachment points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
