*The Kensington and Chelsea (Charged-For Parking Places) (Amendment No. *) Order 2022*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea (hereinafter referred to as “the Council”) propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

- iii) Outside No. 82 Petworth Gardens, Hillingdon
- iv) Outside No. 6 Cromwell Road, Hayes

8. Convert the section of existing ‘Monday to Friday 9am to 5pm’ waiting restrictions on Glebe Avenue, Ickenham opposite the junction with Sussex Road to ‘at any time’ waiting restrictions.
