The site is in PTAL 3 London plan require 1 space per dwelling which has been provided in the form of 4 carports immediately opposite the proposed houses. Cycle store as also being provided on site. The previous application was determined on the basis of one space per residential unit and the officer in his report had no issue standard being applied. The report also raise no issue with the existing service road and turning space which comply with the relevant guidance.

The proposal therefore will not have a significant impact on transport and Highway matters.

Referring the previous planning application on the site determined recently, the officer has written in his report that there are no record site held in the land contamination files. There was a recommendation if planning was granted that a standard conditions would be imposed. For the purpose of being consistent with this previous decision I would ask that this application for class MA be determined in the same way which will mean that there is no risk of contamination affecting the proposed residential accommodation.
