Pre-application advice (ref 77124/PRC/2026/9, dated 25 March 2026) was sought for a scheme comprising a rear dormer and two front rooflights, following refusal 77124/APP/2024/1256 and dismissed appeal APP/R5510/D/24/3348899. The officer advised that a rear dormer of any form is unlikely to be supported, given the Inspector's comments on maintaining the simple, unaltered roofline of the terrace, and that the proposal as then presented could not be supported for that reason alone. No concerns were raised in respect of the rooflights, and the advice confirmed no harm to neighbouring amenity, no highways impact, and no CIL liability. In direct response, this application omits the dormer entirely and proposes rooflights only, with the existing roof form, ridge and eaves retained unaltered.
