Based on the information provided the Highway Authority would not have any in principle objections to the proposal. On this basis, the proposals appear to accord with the requirements of Policies DMCI 1A and DMHB 11 of the Hillingdon Local Plan: Part Two - Development Management Policies 2020) and could be supported by the Council.
