There are a few alterations proposed with this application which are described below with explanation of being lawful -

1. Addition of a porch:

A porch has been added to the house with an external area of under 3m². Also, the height of structure is under 3m. The porch is much more than 2m away from the boundary with a highway

2. 3m Rear Extension:

The original property boundary is stepped, so as per permitted development rights, the property is extended 3m from each rear side of the step to accommodate for a bigger living and kitchen space.

3. Loft addition:

A loft has been added to the roof to add another family room. Considering the property is terraced, the overall volume of the loft is way under 40m³ to be lawful under permitted development rights. The loft volume is 13.3m³.

The proposed drawings carefully show that the loft rear wall do not extend past the original rear wall and have a 200mm offset from the eaves and edge of the property on terraced house sides.
