- (a) any part of the dwelling house would, as a result of works, exceed the height of the highest part of the existing roof;
- (b) any part of the dwelling house would, as a result of works, extend beyond the plane of any existing roof slope which forms the principle elevation of the dwelling house and fronts the highway;
- (c) the cubic content of the resulting roof space would exceed the cubic content of the original roof space by more than
 - i. 40 cubic metres in the case of a terrace house or
 - ii. 50cu.mts. in any other case
- (d) It would consist of or include
 - i. The construction or provision of a veranda, balcony or raised platform or
 - ii. The installation, alteration or replacement of chimney, flue or soil and vent pipe or;
- (e) The dwelling house is on article 1(5) land.
