Demolition of the existing single story back extension and partially demolishing garage at the back of the property. Erection of new single story extension (5.5 m to the rear), and granny annex partially located on the existing garage footprint.

HOUSE EXTENSION : proposed extension will extend by 5.5m beyond the rear wall of the original house and extend to the side by 2.02 m. Flat roof proposed with maximum eaves height to be 2.8m . Existing extension to be demolished.
