Amendments Summary

I have reviewed the refusal documents, and with my architect have made the following revisions; 1) The front dormer has been lowered and reduced in size, to reduce the visual scale and massing of the extension, as noted in the comments on the refusal. 2) The proposed front balcony width has been reduced, to the same size as the existing balcony below, and similar to the three-storey Wren Drive balconies (see location plan photos), at a similar nearby development, built by the same developer Durkan homes. 3) The proposed front balcony fenestration has been reduced in size to a similar size as the existing fenestration below. Also as per the comments regarding hierarchy of windows size with increased height. 4) Two small rooflights have been added to the front dormer, to compensate for reduced incoming light from the revised smaller windows/glazing. Overall the changes have been made, to reduce the overall size of the front dormer; to create a more balanced visual appearance; and to propose a dormer that fits well with the shape of the front of the building. It is also worth noting that the closest properties in Osprey Close do not face the proposed dormer, or have any facing windows, so changes may have little to no impact on nearby neighbours.
