REFUSAL OF PLANNING PERMISSION

The Council of the London Borough of Hillingdon as the Local Planning Authority within the meaning of the above Act and associated Orders **REFUSES**: permission for the following:-

Description:

Erection of a single storey rear extension, extension and conversion of roof space to habitable use to include a Juliette balcony and 6 x roof lights, including demolition of the rear garage and covered space

Permission is refused for the reason(s) listed below:-

1. The proposed roof alterations by reason of their size, bulk, scale and design would represent an incongruous and visually intrusive form of development which would be detrimental to the character and appearance of the host dwelling, group value of the bungalows on this side of Walford Road and the visual amenity of the street scene and the surrounding area. The proposal would, therefore, be contrary to Policy BE1 of the Hillingdon Local Plan: Part One - Strategic Policies (November 2011) and Policies DMHD1 and DMHB 11 of the Hillingdon Local Plan Part Two: Development Management Policies (2020).

If you want to appeal, the deadline is 12 weeks from the date on the decision letter, or 4 weeks if you've received an enforcement notice. Around 1 in 3 appeals is successful.
